## RESOLUTION NO. 09-08

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF McCALL, VALLEY COUNTY, IDAHO, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE MUNICIPAL ELECTION HELD ON AUGUST 4, 2009 FOR THE PURPOSE OF CONSIDERING THE FOLLOWING QUESTION: "SHALL THE CITY OF MCCALL RETAIN ITS ORGANIZATION UNDER THE 'COUNCIL-MANAGER PLAN'?", AND PROVIDING AN EFFECTIVE DATE

WHEREAS, a municipal election was duly held on August 4, 2009, for the purpose of considering the following question: "Shall the City of McCall retain its organization under the 'Council-Manager plan'?"; and

WHEREAS, the judges and clerks of the election have conducted the election and made their return in the manner provided by law; and

WHEREAS, the City Council now desires to canvass the votes and to declare the results of the election.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF McCALL, VALLEY COUNTY, IDAHO, as follows:

### Section 1: ELECTION

The municipal election of August 4, 2009, was duly and regularly called, noticed, held, and conducted, the votes cast thereat received and canvassed, and the returns thereof made in the time, form, and manner required by law and by the ordinances, resolutions, and proceedings taken by the City.

### Section 2: NOTICE OF ELECTION

Notice of the municipal election was duly and legally given prior to said election by the publication of appropriate notice in the official newspaper of the City prior to the election, the first publication being at least 45 days prior to the election, followed by additional notice being published at least fifteen (15) days prior to the date of the election.

### Section 3: POLLS

The polls of the municipal election were opened at 8:00 o'clock A.M. on August 4, 2009, and remained open continuously until closed at the hour of 8:00 o'clock P.M., at the polling place designated by the City Clerk.

### Section 4: QUALIFIED ELECTORS

Only persons who were, on August 4, 2009, qualified electors of the City, within the meaning of Article 6, Section 2, Idaho Constitution, and Section 50-413, Idaho Code, eighteen (18) years of age or older, citizens of the United States and of the State of Idaho and who had been bona fide residents of the City for at least thirty (30) days preceding the election, duly registered to vote therein, were permitted to vote at the municipal election, and no person qualified to vote at said election was refused the right to vote.

Section 5: BALLOTS

The ballots used at the municipal election were in the form prescribed by law. A sample ballot, in the form prescribed by law, was posted in at least three (3) public places within the City and published twice in the official newspaper of the City, as provided by law.

Section 6: CANVASS

The City Council has examined the returns of the municipal election and hereby canvasses the returns of the election.

**SUMMARY STATEMENT:**

The Payette Lakes Classic Wooden Boat Show is requesting permission to hang a highway banner to promote their Wooden Boat Show taking place on August 14-16 at the Shore Lodge. They have requested permission to hang the banner from August 7 – 17, 2009.

They have also requested to hang the banner across Hwy 55 on the west side of town in front of Shore Lodge. The regular banner location at the south end of town near Jacob Street is already booked. If the application to hang the banner is approved, Rick Mooney of Shore Lodge will hang the banner on an existing cable across the highway, near the entrance to the Shore Lodge. The cable is attached to an abandoned utility pole and a tree, both located in the right-of-way.

There are currently no provisions in the City’s highway banner system for a banner to be hung at that location. Staff is in the process of reviewing the banner guidelines and City code and will consider the possibility of having this west-side location in the program. In order to accommodate this event, and in consideration of the facts that there are an existing cable across the highway and Shore Lodge personnel will install and remove the banner, staff recommends a one-time approval for this location. Revisions to the banner program and guidelines will be presented for Council’s consideration at a future date.

<b>SUMMARY STATEMENT:</b>			
<p>The 2009 Chip Seal project was put out for bid through the formal bid process. Bid opening was July 23, 2009. One (1) bid was received, from Snake River Construction of Twin Falls, ID in the amount of \$89,681.18.</p> <p>The budgeted amount for this project is \$82,969.00. The difference of \$6,712.18 will be covered by cost savings in the Streets Fund fuel budget.</p> <p>The project involves chip sealing 2.21 miles of city streets, specifically: 1) Deinhard Lane from Hwy 55 to Spring Mtn Blvd, and 2) Spring Mtn Blvd from Deinhard Lane to Sand Wedge Court. These road sections were chosen because they are heavily travelled and in fairly good condition to accept the chip seal.</p> <p>The Chip Seal project is scheduled to be completed over two days sometime between August 10<sup>th</sup> and August 21<sup>st</sup>. The final date will be set with the contractor.</p>

<p>The construction contract for the replacement of Lift Station 8 was put out for bid through the formal bid process. The bid opening was July 17, 2009. Four (4) bids were received: Sommer Construction \$287,204.65; Bodiford Construction \$321,720; P&amp;M Excavators \$339,207; and Hills Construction \$681,502. The low bid by Sommer Construction has been reviewed, and city engineer CH2M Hill and city staff recommend award to Sommer Construction.</p> <p>This project is scheduled to be completed by December 2009. The replacement lift station itself is being purchased separately from Smith &amp; Loveless and will be delivered Sept. 15, 2009. This construction contract is for the installation and set up of the new lift station. The expenses for this project have been budgeted in FY09 and FY10. See attached cost summary for the project.</p>
