WHEREAS, Larry Smith attended schools in St Louis, Missouri and Indiana; and  
WHEREAS, Larry Smith obtained his private pilot's license in 1938 and was an active  
pilot for 40 years; and*

*WHEREAS, Larry Smith Graduated from the University of Chicago in 1938; and  
WHEREAS, Larry Smith moved to San Francisco and joined Kaiser Shipbuilding in  
1940; and*

*WHEREAS, Larry Smith and his wife Barbara moved to McCall in 1989; and  
WHEREAS, Larry Smith dedicated the net pen dock, piers, and amenities to the city on  
July 25, 1991; and*

*WHEREAS, Larry Smith was elected Mayor of McCall for the 1992-1994 term; and  
WHEREAS, Larry Smith served as Chairman for the Long Valley County Economic  
Development Center in 1991-2001*

*WHEREAS, Larry Smith Managed the McCall Office of the Idaho Small Business  
Development Center in 1995-2006; and*

*WHEREAS, Larry Smith was the Secretary -Treasurer of the Fairway Ridge Homeowners  
Association from 2002-2015; and*

*WHEREAS, Larry Smith was on the board of AFTIM "Assistance for Those In Need"  
Organization from 2010-2013; and*

*WHEREAS, Larry Smith was on the Board of Trustees of the McCall Congregational  
Church from 2008—2010; and*

*WHEREAS, Larry Smith was the Moderator of the McCall Community Church thru  
2012; and*
