### How to fill out the above form

- Once you have completed a Vendor Permit a Business License number will be issued to you.
- Starting at the top left hand corner of this form, please fill in your **Vendor Permit Number**. This is very important for accurate book keeping.
- Date of Event** will be from the first day of the event to the last day of the event you are participating in. You will have until the 20<sup>th</sup> of the following month from the last day of the event to file your taxes with the city of McCall.
- Business Taxpayer name** record the name of your business, again this is very important for accurate book keeping.
- If your business has had any changes such as an address change or ownership of business change, since you last did business in the City of McCall, please indicate these changes in the space labeled **Address** and mark the appropriate squares in the bottom of the form.
- Make sure all information is filled out and accurate in the spaces provided on the left hand side of the form. Line 8 is the total amount due the city.
- If you should have no sales for this event, simply write -0- in the amount due and submit the voucher.
- All vouchers must be signed to be valid.** Make checks payable to city of McCall.
