Short Term Rental Inspections by Dec. 31st

McCall City Urges Vacation Rental Owners and Managers to Schedule Fire Inspections before Year-End Deadline. Given the high demand and limited availability, those who delay might have to wait, potentially causing disruptions in their rental operations.



Business & Snow Removal Permit Renewals

Doing Business in McCall requires a license that is issued to businesses operating from a location within city limits. Commercial Snow Removal Operators and General Contractors working within the city limits must also be licensed because they affect the City's rights-of-way. You must have a Vendor Permit if you do business in McCall but are located outside City limits. Sign Reminders – Sorry no sandwich boards

All commercial signs need a permit, except for specific exemptions in Title 3 of the McCall City Code. Prohibited Sign Types include A-Frame signs, Banners, and other moveable signs like Sandwich Boards. Why? These signs disrupt accessible spaces and public aesthetics. City Staff is happy to help you explore appropriate signs to boost business and pedestrian traffic.



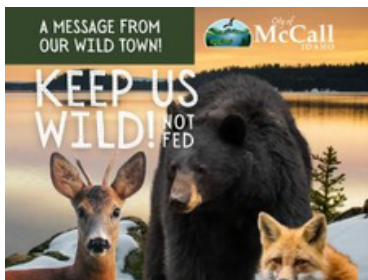
Local Option Tax
