The City Clerk is also responsible for all processing of business, taxi, pawnbroker, child daycare licenses, commercial snow removal, vendor and short-term rental permits, and public event applications.

SUMMARY STATEMENT:

Idaho Transportation Department (ITD) has awarded the City of McCall a Local Transportation Program Grant in the amount of \$1,859,000 to support construction of the 2024 Davis Avenue Phase 2 project, which will provide CRABS reconstruction of the roadway from Reedy Ln. to Lick Creek Rd. with a widened shoulder pathway for pedestrians and bicycles.

The Local Transportation Grant program is a one-time opportunity funded with surplus State General Funds to facilitate local transportation projects in rural areas. There is no local funding match commitment required.

MEMORANDUM OF UNDERSTANDING BETWEEN THE IDAHO TRANSPORTATION DEPARTMENT AND THE CITY OF MCCALL

To provide the agreement guidelines for the Idaho Transportation Department (ITD) and the City of McCall (GRANT RECIPIENT), hereinafter "Party" or "Parties", in cooperative endeavors within each agency's scope of responsibility related to the FY2024 Strategic Initiatives Program Local Transportation Grant Program.

AUTHORITY:

Idaho Code 40-719 created the Strategic Initiatives Grant Program and established the Strategic Initiatives Grant Program Fund, and Senate Bill No. 1189 appropriated funds to ITD for FY2024. Idaho Code section 40-317 and Idaho Code sections 67-2326 through 2333 and 67-2339.

AWARD AMOUNT AND PROJECT DESCRIPTION:

\$1,859,000.00 is approved from the Strategic Initiatives Grant Program for Grant Recipient's project as described in their application attached as Exhibit A for Davis Ave Reconstruction Phase 2Pavement Rehabilitation.

ITD RESPONSIBILITIES:

- To ensure the Strategic Initiatives Grant Program is used to mitigate the impact of state highway
 projects on local roads or for economically significant local transportation projects that require the
 assistance of ITD to facilitate funding.
- 2. Review Grant Recipient's provided information outlined below and concur in project readiness before processing fund transfer(s) from the Strategic Initiatives Grant Program Fund to the Grant Recipient, and process funding transfer within 30 days of approving the Grant Recipient's request for construction funding.

- 6. Provide construction oversight and project administration.

- 7. Provide an annual update on the project status no later than September 30, beginning in 2024.
- 8. Complete project construction, including any change orders or other contract adjustments.
- 9. Provide a final close-out report including a summary of project accounting, with before and after pictures upon project completion.
- 10. Responsible for answering media, public or government inquires related to the expenditures of these funds.

LIMITATIONS:

Nothing in this MOU between the Parties shall be construed as limiting or expanding the statutory or regulatory responsibilities of any involved individual in performing functions granted to them by law; or as requiring either entity to expend any sum in excess of its respective appropriation. Each and every provision of this MOU is subject to the laws and regulations of the state of Idaho and of the United States. Nothing in this MOU shall be construed as expanding the liability of the Parties. In the event of a liability claim, each Party shall defend their own interests. No Party shall be required to provide indemnification of the other Parties.

EFFECTIVE DATE:

This MOU shall become effective upon the most recent signature by authorized representative of the Director, Idaho Transportation Department, and the authorized representative for the Grant Recipient, and will remain in force unless formally terminated by both Parties.

METHOD OF AMENDMENT OR TERMINATION:

Amendments or requests for termination of this MOU may be proposed in writing at any time by any Party. Amendments will become effective upon signature by all Parties to this MOU and shall be attached to this MOU and made a part thereof.

CONFLICTING PROVISION:

If any provision of this MOU shall contravene any statute or Constitutional provision or amendment, either now in effect or which may, during the course of this MOU be enacted, then that conflicting provision in the MOU shall be deemed null and void. In the event any provision of this MOU is determined null and void, all remaining provisions shall remain in full force and effect.

Question 1. Project Description and Need

The Davis Ave. Reconstruction Phase 2 Project will complete reconstruction of approximately 2175 lineal feet of roadway from the southerly intersection with Blue Water Circle north to the Ponderosa State Park entrance at the intersection of Lick Creek Road within the city limits of McCall, Idaho. The City of McCall intended to complete reconstruction of this length of roadway in 2023 as part of a larger project planned to improve the full length of Davis Ave. from Thompson Ave. to Lick Creek Road. Unfortunately, higher than expected bid proposal amounts made the full project financially impossible to accomplish with only local funds so the project had to be split into two phases. The City of McCall completed Phase 1 (Davis Ave. from Thompson Ave. to Blue Water Circle) in 2023 and is now requesting \$2,000,000 in grant funding to support Phase 2 of the Davis Ave. Reconstruction Project so that the full length of roadway will be improved and have common profile, surfacing condition, roadway width, and lifecycle maintenance needs.

This project was selected for the Local Transportation Grant Program funding program because:

- Davis Ave. is the primary route to Ponderosa State Park and critical to the region's tourism-based economy. With an annual visitation of over 630,000 people, Ponderosa State Park is one of McCall's primary destinations, contributing significantly to the local economy. Visitors traveling from State Highway 55 can most directly access Ponderosa State Park, and/or recreation destinations beyond, by using Davis Ave.
- Davis Ave. is a Major Collector and is used by large vehicles such as RVs and trucks with trailers. The Average Daily Traffic (ADT) measured in 2022 for the project area showed a summer daily volume of 5462 vehicles with more than half of these being cars/trucks with trailers and/or multi-axel vehicles, contributing to a high equivalent single axel load and wear and tear on the roadway surface.
- The pavement surface has reached the point of needing complete reconstruction. The deterioration of the pavement is exacerbated by large longitudinal/fatigue/alligator cracking, broken edges, potholes, depressions, and raveling. The project area has a Remaining Service Life of 0-4 years and simply cannot continue to be patched or sealed; complete reconstruction is becoming increasingly necessary.
- Davis Ave is a safety hazard for pedestrians and bicyclists. Currently, Davis Ave. has no defined shoulder or bike/pedestrian facilities. Walkers and bicyclists must share the 11 ft. wide travel lanes with vehicles, which are often large RVs and trucks with trailers. The project will improve safety by adding 5ft. wide paved shoulders to each side of the roadway.

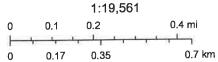

Question 2. Project scope and schedule

The Davis Ave. Reconstruction Phase 2 Project will complete full-depth reconstruction of approximately 2175 lineal feet of roadway from the southerly intersection with Blue Water Circle north to the Ponderosa State Park entrance at the intersection of Lick Creek Road and will include:

- Site preparation including mobilization, traffic control, sediment control, clearing, grubbing, and asphalt removal; and
- Cement recycled asphalt base stabilization (CRABS) pavement rehabilitation of the existing roadway; and
- Widening of roadway surface to provide 5ft paved shoulders on both sides of the roadway; and
- Construction of approximately 595 linear feet of 8ft. separated paved pathway along cityowned property to accommodate a larger stormwater drainage swale and to tie into the existing municipal Golf Course public pathway system; and
- Installation of stormwater inlets and piping and driveway culverts; and
- Traffic signage and striping of roadway and new crosswalk delineation at Lick Creek Road intersection (Ponderosa State Park entrance); and
- Disturbed soil stabilization through seeding and landscape repair.

Note: As a "Dig Once" strategy, improvement of underground utilities (i.e., water) will likely occur in conjunction with this roadway project but are funded though utility-specific dedicated funds and are not included in this project budget or scope.

Budget Summary: The cost of the Davis Ave Reconstruction Phase 2 project is estimated by Horrocks engineers, based upon 2023 received bid results for Phase 1, to total \$2,128,758. The total grant request is \$2,000,000, with the balance of \$128,758 provided by City of McCall Local Option Tax revenue.

Anticipated Project Schedule: Since plans and bid documents for a larger project that originally included this project scope were prepared but unable to be constructed due to higher than anticipated construction costs, preparation for bidding of the proposed project is minimal and the project can be launched as soon as funding is awarded. The project can confidently be ready for construction as soon as snow melt and weather conditions allow in spring 2024 as summarized in the table below:

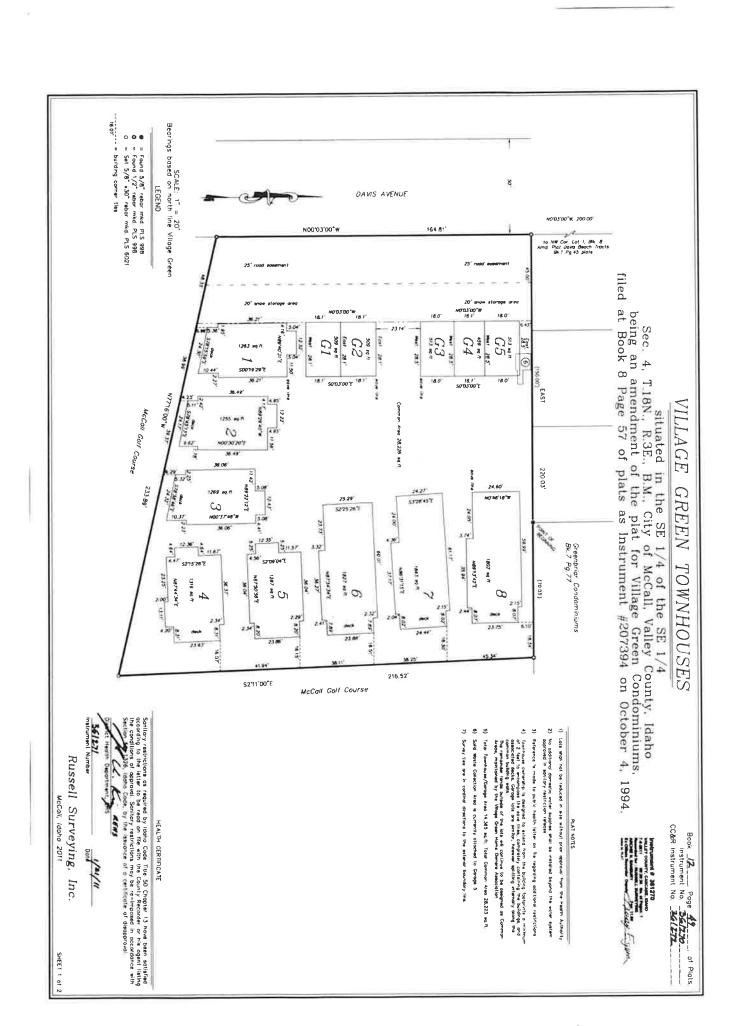

Question 3. Right of Way

The project will occur primarily within the existing Davis Ave. Right of Way except for a portion along the Village Green Townhouses development at 1695 Davis Ave, which has an existing 25 ft wide road easement dedicated by plat to the City of McCall. Additionally, temporary construction easements will be acquired from each property owner so that private driveways can be tied into the roadway improvements. Typically, these temporary easements are established once the project funded, and the construction timeline is set.

Question 4. Are your engineering plans ready to bid or will they be ready within 6 months of grant award? Provide explanation of progress to date, and evidence of current project development (plan set).

The Davis Ave. Reconstruction Phase 2 Project is "shovel-ready" and can proceed to bidding within 90 days of funding award with only minor updates to the plan set and prepared bid packet needed. A final design plan set and bid packet for reconstruction of Davis Ave. from Thompson Ave to Lick Creek Rd. was completed by Horrocks engineers in January 2023, because the City of McCall intended to complete the proposed project (reconstruction of Davis Ave. from Blue Water Circle to Lick Creek Rd.) as part of a larger effort to improve the full length of Davis Ave. However, the City was forced to break the project into two phases when rapidly rising construction costs made the full project financially impossible to accomplish with only local funds. The City of McCall funded and completed Phase 1 of the project (Davis Ave. from Thompson Ave to Blue Water Circle) in summer 2023 and is now requesting grant funding to support Phase 2 of the Davis Ave Reconstruction Project (Blue Water Circle to Lick Creek Road).

Note: Although the attached plan set indicates bid alternatives, none of these are proposed as part of this Davis Ave. Reconstruction Phase 2 Project grant request scope or budget.

Consistent with prior years, the attached resolution authorizes the City Clerk to conduct a bid auction for the purposes of selling the surplus and abandoned property to the highest bidder. The City has partnered with Public Surplus, an online auction to auction our surplus items. The public auction on the Public Surplus auction website will be noticed in the Star-News for two consecutive weeks and not less than five (5) days prior to auction.

The City of McCall has provided \$133,125 in local match for the FY24 fiscal year to Mountain Community Transit (MCT). MCT provides transit service within the City of McCall and the commuter route connecting McCall, Donnelly, and Cascade.

The 5311 rural grant provides funding to maintain our current red, green, and blue line routes that have served 44,277 passenger trips in FY23. There is a need for additional service if funding is available. TVT is applying for a 5339 capital grant that will replace three buses (red line, blue line, and green line) that will have met their useful life. TVT is also applying for CARES Act funding through a one-time grant application. This grant is critical, as the cost of labor, fuel and services has increased beyond the level of rural grant dollars currently available.

The Idaho Public Transportation Plan 2018 identified needs, priorities, opportunities and potential solutions for public transportation within District 3, which includes Valley County. Maintaining existing service was the number one priority.

Mountain Community Transit provides a valuable service to the residents, businesses and tourists of McCall. This has been demonstrated by the ridership and continued community support for the transit service.

The City of McCall strongly supports Treasure Valley Transit's FY25-26 5311 and 5339 rural grant applications and the CARES Act one-time grant application.

As you've likely heard by now, the McCall Chamber of Commerce has made some changes to the format of Winter Carnival, moving it to the last weekend in February and consolidating the event to three days. The Chamber Board of Directors, a group of local people who volunteer their time in support of our local business community, want the entire community to know that we did not take the decision to make these changes lightly.

When the Chamber first hosted Winter Carnival in the 1960's, the goal was to raise awareness about McCall as a winter destination. Sometime in the 90's, the event was expanded to 10 days because, at that time, winter weekends were not particularly busy. Fast forward to present day, and McCall's midwinter weekends are vibrant and bustling. The additional surge of visitors that comes with Winter Carnival has put considerable stress on public services and local businesses.

A 2015 study by the University of Idaho shows as many as 60,000 people have converged on McCall during the 10-Day Festival in recent years. With a shortage of affordable housing resulting in a shortage of employees, many local businesses in the downtown core have been telling us they are overwhelmed by those Winter Carnival crowds, with several legacy businesses even making the difficult choice to shut down during the two weekends of winter carnival.

After considering years of feedback and input from local businesses and community members old and new, the Chamber Board went looking for solutions. Canceling Carnival was not an option. Instead, the Board, made of up community-focused representatives from a wide variety of local businesses, decided it was time to try something new. Instead of inviting a huge surge of carnival visitors right at the peak of winter recreation season, the Board took on the challenge of trying to reimagine the event in a more sustainable way that would help even out the peaks and valleys of winter tourism, while holding on to our cherished traditions.

This year and next, Carnival will be held at the end of February. 2024 dates are February 23, 24, 25 (2025 dates are February 21, 22, and 23). All of the most treasured events will still take place, from Chamberhosted events like the Kid's Torchlight and Mardi Gras Parades, to the Fireworks Show, Music on the Main Stage, and of course, the Snow Sculpture contest - along with events like the Monster Dog Pull and Snowshoe Golf, which are hosted by other community organizations.

Some of the factors used to make this decision include:

- U.S. Census data shows McCall's population grew 32% from 2011 and 2021 from just short of 3000 permanent residents to nearly 4000.
- While the permanent population grew by nearly a third, tourist visitation has more than tripled during peak periods. A common metric to measure tourism levels in McCall is the city's lodging

LOT tax collections. Over the ten-year period from 2013 to 2023, Winter (December – March) Lodging LOT collections were up 345% when adjusted for inflation.

- It's worth noting that those trends held true even in 2021 when Winter Carnival was canceled due to the COVID-19 Pandemic, a testament to the appeal of the McCall area's winter activities, even without Winter Carnival in the mix.
- A 2021 survey of Chamber members showed that 82.5% reported that canceling the Carnival had no negative impact on their business.
- 80% reported winter business was up during the winter when there was no Carnival (2021).
- 70% of member businesses supported either shortening the Carnival to one weekend or moving it later in the winter (only 30% voted for no change).

These changes are meant to strike a delicate balance between the needs of the Chamber's business members, the visitors who love the event, the local people who treasure Winter Carnival traditions, and the realities of modern life in this rare and special community.

Naturally, the McCall Chamber of Commerce will be seeking feedback from the business community and local community members on the changes to see if they've had the intended positive effects and if there are any unanticipated negatives. Our organization is committed to figuring out how to make Winter Carnival sustainable in the modern era and will continue to ask our community members to help us create a vibrant future for the beloved event.

Carnival FAQs

WHY DID YOU CHANGE WINTER CARNIVAL?

In recent years, McCall's 10-day Winter Carnival has drawn as many as 60,000 tourists to McCall, which has less than 4,000 year-round residents. Trying to find enough staff to handle that sort of surge has proven extremely difficult for local businesses, especially those in the heart of McCall where most Winter Carnival events are held. In recent years, several well-established downtown businesses opted to close during Winter Carnival rather than provide their guests with service below their normal standards.

Winter Carnival is organized by the McCall Chamber of Commerce. The Chamber exists to serve the interests of our local business community and our community members at large. Several years of feedback convinced the Chamber that the 10-Day, mid-winter format was no longer working for the community, which made our signature winter festival more of a burden than a blessing to the town. Rather than cancel Winter Carnival, the McCall Chamber decided to change the format in an effort to preserve beloved traditions while minimizing the negative impacts of the sprawling event on our community.

WHY DID YOU CHANGE THE DATES?

Many of the members who provided feedback felt that it was counterproductive to host Winter Carnival during two consecutive winter weekends when our area experiences some of its best snow conditions of the season. The last weekend of January and first weekend of February are prime weekends for snow-sports enthusiasts to visit the area. Many of those visitors were getting pushed out by carnival crowds right when conditions were ideal for them to enjoy the best snow conditions of the year. Organizers felt carnival-goers could have an equally good experience at the end of February as the high-country snow conditions have less of an impact on the quality of their experience.

WHY DID YOU SHORTEN IT TO THREE DAYS?

Several concerns influenced the choice to consolidate the event. The first was to contain any negative impacts to a single weekend instead of a longer period. Another consideration was cost. One of the biggest expenses for Winter Carnival is the Fireworks Shows, which have increased in cost dramatically in recent years. There were two fireworks shows in the 10-day format and a three-day format allows for a single fireworks show. The 10-day stretch of events requires a massive volunteer effort. In recent years we've seen a dramatic drop in the availability of volunteers. Many of our local townspeople have expressed that increased visitation with decreased employee availability has left them with no extra time to volunteer during Winter Carnival.

AREN'T YOU WORRIED ABOUT LOCAL BUSINESSES LOSING BUSINESS?

This was a major concern for years as we considered making changes to Winter Carnival, but an unintended experiment during COVID gave us the confidence to make the change. Carnival was canceled for health and safety reasons in 2021, and a survey of our members reported that revenues were actually UP

for January and February. Even outside of COVID-era trends, McCall has seen an enormous surge in visitation during the months of January and February. The McCall Chamber uses city lodging tax collections to measure tourist visitation levels. Over the course of 10 years, (FY13 - FY22), lodging tax collections in McCall more than tripled during the months of January and February, increasing by 201.5%.

WHAT ABOUT THE SNOW SCULPTURES MELTING?

That was another big concern, as the snow sculptures are a key part of what makes McCall's Winter Carnival so magical. We carefully analyzed what the weather data shows about temperatures at the beginning of February versus the end of February, and found the difference was negligible. We were surprised to learn that McCall actually sees MORE RAIN in the month of January than during February, which gave us confidence in trying the new dates.

DON'T YOU CARE ABOUT THE WINTER CARNIVAL TRADITIONS?

Of course! The McCall Chamber of Commerce has been the organization behind the Winter Carnival since the 1960s, and we treasure the memories that have been made over the past six decades. When re-imaging the event, we did an inventory of which events were most meaningful to the largest number of our residents and made sure those events would continue.

WHAT IS THIS YEAR'S THEME?

This year's theme, "Color Outside the Lines," pays homage to the re-imagined event, which is focused on making Winter Carnival meaningful for locals again. It's also meant to honor our educators, from Council to Cascade, and everywhere in between. Their steadfast presence in our community and dedication to excellence has inspired generations of young people to dream big and chart their own course, even if that means coloring outside the lines.

WHAT WILL WINTER CARNIVAL 2024 BE LIKE?

Winter Carnival will be a lot like it has been in the past, just shorter and a few weeks later in the winter. Sculptures will line the streets of McCall and carnival-goers can enjoy favorite events, including The Children's Torchlight Parade, the Mardi Gras Parade, Snowshoe Golf, Tiki Torch Treks at the McCall Golf Course, McCall Starz on Ice Figure Skating Shows, the Monster Dog Pull, and of course Fireworks on the Lake, a vendor court, beer garden and live music on the Main Stage.

WHAT IF IT DOESN'T WORK?

We know visitors like to book their lodging for Winter Carnival in advance, so we've committed to this format for the next two years, 2024 and 2025. We will continue to seek feedback from our business community, volunteers, and local residents to evaluate the impact of the changes on the event and the community at large. That feedback will help inform our plans for Winter Carnival moving forward.

SUMMARY STATEMENT:

During the process of developing the City's ADA Transition Plan, staff learned that an annual progress report should be made to Council. The report should compile an annual summary of the previous year's progress in making McCall more accessible. Not only does the annual report give an opportunity to showcase the City 's commitment to the public, but it also serves as a way to document changes to the implementation schedule. The Annual Report includes a summary of actions taken to modify or modernize policies and programs, as well as any City-specific projects that addressed accessibility needs.

Priorities may change over time and the City may be the recipient of grants for specific projects that may cause one priority project to advance in schedule ahead of another. Any changes in schedule should be included in the recommended Annual Progress Report that outlines the progress the City is making each year on implementing the recommendations of Access McCall.

The important step to take each year is to update the schedule and document why things changed by incorporating that into the Annual Progress Report as a formal amendment to the Schedule. By doing this, the City limits its legal exposure if someone were to file a grievance challenging the City's delay of a project or its inability to meet the Schedule's recommendations. This is the first ADA annual report and is limited as the City has just adopted the plan in January of 2023. Attached are Chapter 9 Schedule and Implementation Steps from Access McCall's ADA Transition Plan and the Annual ADA Progress report.

REPORT OVERVIEW:

This report has been prepared in accordance with the City of McCall's Access McCall ADA Transition Plan and Self-Assessment Adopted by the McCall City Council on February 9, 2023. Areas covered in this report include the following:

- a) Data Overview Outline the ADA complaints that were received in 2023, including any action taken by the City of McCall to resolve.
- b) Accomplishment Report List of accomplishments and/or projects undertaken in 2023 to address deficiencies relevant to ADA.

POLICY STATEMENT:

The Americans with Disabilities Act (ADA), enacted on July 26, 1990, provides comprehensive civil rights protections to persons with disabilities in the areas of employment, state and local government services, access to public accommodations, transportation, and telecommunications. The ADA is divided into five titles that relate to different facets of public life. These are summarized in Figure ES – 1 Title II of the ADA is what Access McCall addresses. Title II prohibits state and local governments from discriminating against persons with disabilities by requiring the City to make all programs, services, and activities accessible to persons with disabilities. Title II requires that a public entity conduct self - evaluation of its services, programs, policies, and practices to determine whether they are following nondiscrimination requirements of the ADA.

Title VI of the Civil Rights Act of 1964, as amended, prohibits discrimination on the basis of race, color, or national origin in programs and activities receiving Federal financial assistance. Specifically, Title VI provides that "no person in the United States shall, on the ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal Financial Assistance" (42 U.S.C. Section 2000d).

Pursuant to Title VI of the Civil Rights Act of 1964, as amended, and the Civil Rights Restoration Act of 1987, the City of McCall, hereinafter referred to as "the City," will not exclude from participation in, deny the benefits of, or subject to discrimination any individual on the grounds of race, color, or national origin, sex, age, disability, limited English proficiency and income status.

COMPLAINTS:

Currently, the City has no outstanding grievances requiring resolution. On the City's website at https://www.mccall.id.us/departments/CityClerk/ADA504 are all the City's policies regarding ADA. Also on this page is instructions on how to file a grievance and an online ADA Grievance form that gets directly routed to the ADA Coordinator.

Grievance procedures are incorporated into the City Access McCall ADA Transition Plan and Self-Assessment document and will continue to be followed as required. The Access McCall ADA Transition Plan and Self-Assessment is available online via the City of McCall website.

ACCOMPLISHMENT REPORT:

Throughout 2023, The City of McCall worked to address deficiencies concerning Title VI / ADA through several projects / training initiatives. Projects are broken down by department, and an overview has been provided below:

Public Works Department:

Privately Funded Projects:

Natural Grocers:

- 1. Through the land use development process Natural Grocers was required to construct approximately 230 linear feet of curb, gutter, and 8-foot-wide sidewalk along State Highway 55. This also included new pedestrian curb ramps to cross the driveway approach, and a new pedestrian ramp to cross State Highway 55.
- 2. These improvements were built in the summer of 2023. Final inspection has not occurred, and these improvements have not been formally accepted by Idaho Transportation Department (ITD) or the City of McCall.

Park Street - Phase 1

- 1. Development was only required to construct half of the roadway, sidewalk, curb, gutter, bike lanes, pavement improvements and stormwater improvements. The City contributed funds to complete a full roadway improvement.
- 2. Approximately 400 linear feet of curb, gutter, and 5.5-foot-wide sidewalk. Two new pedestrian ramps were installed at the intersections where the new sidewalk was installed.
- 3. Final Completion at the end of Fiscal Year 2021

Publicly Funded Projects:

Senior Center

1. Improvements to the site surrounding the Senior Center, which includes improved pedestrian connectivity, paving the parking lot, new ADA parking spaces, new traffic configuration, realigned pathway, more green space, improved drainage and stormwater facilities.

- 2. Final Completion at the beginning of Fiscal Year 2023
- 3. Total Cost: ~\$400,000, a Community Block Development Grant (CBDG) for \$195,000.
- 4. Accessible Improvement Costs: ~135,000

Park Street – Phase 2

- 1. Improvements to the roadway and built sidewalks on the northern side of the roadway to connect to sidewalk that was previously constructed. The project also improved stormwater conveyance in the project area.
- 2. Approximately 860 linear feet of curb, gutter, and 5.5-foot-wide sidewalk. Four new pedestrian ramps were installed at the intersections where the new sidewalk was installed.
- 3. Final Completion at the end of Fiscal Year 2023
- 4. Total Cost: ~\$1,100,000. Accessible Improvement Costs: ~\$115,000

Davis/Thompson - Phase 1

- 1. Improvements to the roadway, water main, and stormwater facilities. With the newly constructed roadways, the paved bike lanes pedestrians will also likely utilize.
- 2. Final Completion at the end of Fiscal Year 2023
- 3. Total Cost: ~3,700,000, Accessible Improvements Costs: ~600,000

Budgeted for FY24:

Public Works Facilities ADA access improvements for building ingress/egress Total budgeted for PW Facilities Improvements \$393,470

Communications Department

The City of McCall Communications Department made significant efforts to enhance accessibility for individuals with disabilities, particularly in the areas of text services, feedback collection and website compatibility. This report outlines the key accomplishments of the communications staff in meeting ADA requirements and improving existing services to better serve the public with disabilities.

Accomplishments:

1. Increased Text Accessibility:

- Recognizing the growing demand for text-based communication, the Communications Department proactively addressed this need by purchasing additional text coverage which cost \$500 in FY 22
- Staff underwent training sessions on effective texting strategies for readers and social media components, ensuring that information is disseminated in a manner accessible to a broader audience.

2. Website Accessibility Evaluation:

- In response to the imperative of making the city's online presence more inclusive, the communications team conducted a comprehensive evaluation of website hosting providers.
- Emphasis was placed on ADA compatibility and the ability of the chosen provider to monitor the site for errors and promptly make necessary repairs.

3. Selection of Aptagey as Website Host Provider is expected:

- After carefully considering and evaluating various providers, the Communications Department expects to choose Aptagey as the new website host provider.
- Aptagey, initially focused on school districts, has expanded its services to municipal governments. It offers a comprehensive solution with both an app and a website, both of which demonstrate top-level compatibility with ADA standards.
- Regular scanning services provided by Aptagey will contribute to ongoing monitoring and maintenance, ensuring the sustained accessibility of the city's digital platforms.
- Extensive customers service and assistance with integrations.

4. Multi-Modal Communication Strategies:

Explored multi-modal communication strategies that cater to various disabilities
that may include the use of audio descriptions, alternative formats for written
content, and ensuring compatibility with assistive technologies throughout our
content.

5. Community Outreach and Feedback Mechanisms:

• Responded to feedback from individuals with disabilities on the effectiveness of current communication initiatives and curated tools to meet their needs on a case by case basis.

6. Training Programs for Staff:

• Continue investing in training programs for communication staff to stay updated on the latest accessibility standards and technologies. This will ensure a proactive approach to meeting evolving ADA requirements.

7. Focus Groups and Information Collection

• Visited with our Senior community in a focus group setting asking about city limitations and how we can meet their needs. Discussions included inclusionary housing requests, sidewalk maintenance, larger signs, options for print out of our relevant documents and ways to collaborate with youth and other volunteers to provide reading, informational and general everyday assistance programs.

Conclusion:

The City of McCall Communications Department has made commendable progress in enhancing accessibility for disabled individuals. By implementing the recommendations outlined above, the department can further solidify its commitment to inclusivity and ensure that communication

strategies align with the diverse needs of the community. The ongoing dedication to ADA compliance will contribute to creating a more accessible and equitable city for all residents.

Parks and Recreation Department

As it relates to the ADA Transition Plan the following list highlights the various projects and maintenance items that can be considered progress towards overall better accessibility in our community. This list includes a combination of completed project implementation, adjustments to maintenance procedures, and design work for future funding and implementation. These accomplishments pertain to the Parks and Recreation Department, however, there is regular coordination and cooperation with other departments to implement and plan for these improvements.

- 1. A temporary ramp was installed and maintained adjacent to the bike path on Dienhard near the post office to better accommodate a request for better access from the road to the pathway. The recent construction project accounts for a fully compliant ramp and the temporary improvements, although not to ADA standards, improved the situation while construction is underway. Signage reflecting the same was also installed to communicate these efforts.
- 2. Two significant sections of sidewalk were replaced in the downtown core to bring infrastructure back into compliance.
- 3. ADA curb cuts and failing truncated domes were assessed for repairs and mitigation efforts were implemented to improve the situation while repair work is designed and scheduled for full retrofits in spring of 2024.
- 4. Rotary Park Restroom (south restroom) was fully remodeled to mitigate accessibility issues. The facility was brought into full ADA compliance as a result and the north restroom is scheduled for similar improvements in spring or fall of 2024.
- 5. Brown Park Restroom is currently being assessed and a scope of work for complete renovations is underway to improve accessibility.
- 6. Currently the Department is working jointly with St. Luke's McCall Hospital in conjunction with their development agreement to create an accessible ADA pathway adjacent to W. Lake Street across the Museum Site which is City owned property.
- 7. Pathway installation in conjunction with the Running Horse Development created a more accessible route from W. Lake Street to the bike lanes on Forest Street getting pedestrian traffic off W. Lake Street / State Highway 55.
- 8. Staff is applying for a TAP Grant to complete the last phase of the Wooley Avenue separated pathway which will improve accessibility and the pedestrian experience between the Wooley Avenue boardwalk and the separated pathway at Davis Street.
- 9. Renovation of the Roosevelt Pocket Park to improve user access was done to ADA standards.
- 10. Recreation staff are researching and assessing the value of purchasing a wheelchair that is more fit for our climate and terrain for the loaner equipment program. Both visitors and

community members could then check it out at no charge in an effort to improve user experience given our challenging weather and climate in McCall.

11. The sink in the American Legion Hall meeting space was replaced with compliant fixtures.

Budgeted in 2024 Additional \$10,000 to implement ADA Transition Plan Design Work

Golf Department

In 2023 the Golf Course rebuilt all existing tees and made new forward tees on the Aspen and Birch courses making them all ADA compatible. The total cost of project was \$595,000.

The golf course went out to bid to upgrade the front entry ramp and stairs to bring them into ADA compliance. The City, however, only received one bid that was 80% over the engineer's estimate so the project was delayed. The City has gone back out to bid with hopes of receiving a qualifying bid to construct in 2024. \$130,331 budgeted in 2024.

2024 Budgeted items: Construct a new pair of ADA compliant restrooms where a portable toilet is now. This will include a safety roof structure for adverse weather conditions. Restrooms will be winterized to be open year-round. Lumber, beams and logs will be recycled from dead trees removed from the golf course. \$40,000 budgeted in 2024 and \$70,262 budgeted for 2025.

Library Department

1. Summary of actions taken to modify or modernize policies and programs, as well as any City-specific projects that addressed accessibility needs:

The front desk has been replaced with a user-friendly, ADA compliant reception desk which will also be used in the upcoming library expansion. A design firm projected our community's needs and cost estimate for this large capital improvement project with their conceptual design for the city campus, endorsed by the City Council in November of 2016. The McCall Library Expansion project had been put on hold for the winter months November 2022-March 2023. This calendar year, the construction site was remobilized according to schedule. As of December 2023, the building, which will be completely ADA accessible, is on track to open to the public in May 2024. This will include several improvements to accessibility, including proper ramps for entrance into the library, proper restrooms, and proper distance between library bookshelves.

2. Estimate of the cost incurred by the City in terms of both human and financial resources to take these actions:

Because of the complexities of this very large project that completely revamps the public library access, it is difficult to parse out the specific dollar amount related to ADA improvements throughout an entire building. The total estimated expenditures from FY22 and FY23 are \$6.1m.

Police Department

The purpose of this memorandum is to provide the McCall City Council with a documented progress report of ADA Transition Plan updates at the McCall Police Department. The McCall Police Department is a leased facility, owned by Valley County, and shares a joint entry with the

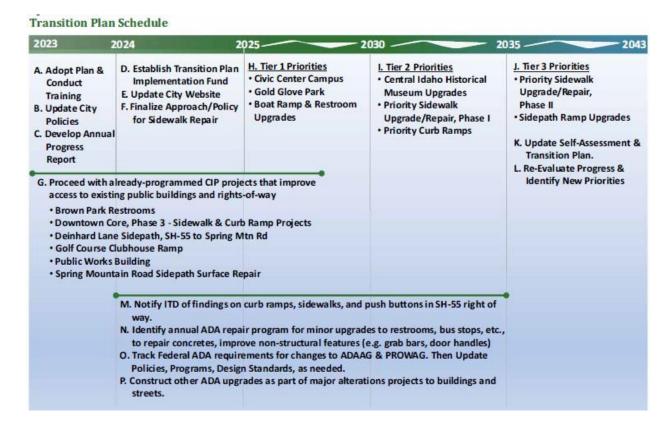
Valley County Probation Department. Per the ADA Transition Plan notes, the City is to inform Valley County as the owner of the property of the findings and provide auxiliary services when requested.

On December 14, 2023, Police Chief Dallas Palmer informed the Valley County Clerk, Doug Miller, of the ADA findings as requested via email. The listed findings are as follows (red text = auxiliary services provided upon observation or request):

- 1. The front entry door to the shared lobby does not meet ADA requirements, due to the lack of an automated door system that would assist those with disabilities in making entry. (MPD front office staff observe the front entry door and can assist those with disabilities in making entry into the facility).
- 2. The facility does not have public access restrooms. (MPD front office staff continuously observe the front lobby area and can escort those requesting a bathroom to the courtroom restroom).

As of now, all ADA Transition Plan findings have been relayed to Valley County and necessary auxiliary services are appropriately in place.

9. Schedule & Implementation Steps

Federal law requires the Transition Plan to have a schedule that shows how the City will address its priorities for accessibility in order to transition its facilities and infrastructure to ADA compliance, over time. The City of McCall's ADA Coordinator is responsible for ensuring the Schedule is managed and updated over time as part of the recommended *Annual Progress Report*.

Figure 9-1 on the following page includes a schedule for implementation of various policy changes, program modifications, and projects. The schedule includes update to policies, programs, and online information in years 2023 and 2024, while establishing the recommended Transition Plan Implementation Fund to begin design and/or construction of projects thereafter. The projects identified as Tier 1, Tier 2, and Tier 3 priorities address the greatest needs for McCall as determined through the Self Assessment phase of *Access McCall*, including public input.

There is no financial pathway for the City to completely upgrade every area of every public building and every public street over the next 20 years. By focusing on the Primary Function Areas (PFA) of public buildings/facilities, as well as priority ramps and sidewalks in public rights-of-way, the City will substantially improve accessibility to the greatest number of people within its fiscal realities. Beyond existing facilities, the City is planning substantial expansion of its pathway network along primary streets in McCall, including Davis Avenue, Wooley Avenue, and Lick Creek Road.

Beyond what is identified in the Schedule, the City should be willing to respond to requests from individuals who have a specific access need accessing a building or street. The same applies to any City employee who identifies an access need for their daily routines in a sector of a building that is not a PFA. Individual requests may be accommodated through the recommended \$50,000 annual Transition Plan Implementation Fund.

It is recommended that the City begin incorporating Tier 1 projects into the next update of its CIP to identify a more specific schedule that identifies years in which design and construction could occur. The City may decide to pursue outside funding via grants or other sources to implement these priority projects and supplement the annual implementation fund allocation.

The availability of funding or the need to pursue outside funding for implementation may impact the scheduling of projects. If a project is advanced to an earlier timeframe in the Schedule, or delayed to a later timeframe, the City should reflect this change as part of its *Annual Progress Report*.

These priorities are not intended to usurp current projects already planned through McCall's Capital Improvements Plan (CIP). Factors such as bids and schedules for other CIP projects may impact the City's overall budget, thus impacting the implementation schedule of ADA-specific projects.

Figure 9-2 (pages 67 and 68) includes more details on the efforts identified in the Schedule. It is recommended that the City include this table as part of its *Annual Progress Report* to incorporate updates on the status of these actions and chart progress on implementing these measures.



The City will continue to make substantial upgrades to its facilities to improve access, like the recent reconstruction of Brown Park and pending upgrade of its restrooms. Some of these projects will be done for purposes other than addressing ADA requirements and should be tracked as part of an Annual Progress Report on the implementation of Access McCall.

SUMMARY STATEMENT:

Library Director Meg Lojek and Project Manager Nathan Stewart have worked closely with consultants to trim the furniture package to the essential pieces necessary to open the newly constructed library space on schedule in May 2024. Our representative from OEC (Office Environment Company), Cailey Ostrowski, has selected pieces using the basis of design provided by Ratio Architects. OEC utilized established furniture joint purchasing agreements (JPA) (e.g. State of Idaho and Omnia), to provide best available pricing available to Idaho municipalities while complying with Idaho procurement rules. OEC professionals also manage the various FFE orders, including shipping, storing and installing the entire package under the direction of the owner, the City of McCall. Staff will be on hand to answer questions.

Included with this agenda bill is the draft contract with OEC's (Quotation #51262), which shows the JPA discounted amount for each item from OEC. Staff and OEC are still evaluating least cost options for all furniture selections to reduce overall costs and will bring the final proposal to the Council for consideration at the meeting.

Approval of this contract in January will allow furniture to be ordered and fabricated in time for the library opening tentatively scheduled for May 2024.

RECOMMENDED ACTION:

Approve the contract with OEC to provide furniture for the library expansion in the amount of \$205,000, authorize staff to manage change orders within 10% of the contract amount, and authorize the Mayor to sign all necessary documents.

Terms and Conditions of Sales Agreement

1. OUOTATIONS AND ORDERS

- a. ACCEPTANCE: A signed quote with an authorized signature and date of acceptance is acceptable. All prices are quoted FOB shipping point and are guaranteed for 30 days from date of quotation.
- b. MODIFICATIONS: Any modifications to an approved and acknowledged order are subject to the Seller's ability to conform and the manufacturer's approval. Changes must be made via revised purchase order or change order.
- c. CUSTOMER REQUIRED DATE: A mutually agreeable delivery date is required for each order and will be used as the Customer Required Date.

2. INVOICING

- a. TIMING: Contract furniture with related installation and other services will be invoiced after substantial delivery of the product to the job site. Direct shipments from manufacturers will be invoiced upon shipment from the manufacturer. Services will be invoiced after the services have been rendered substantially complete.
- b. PAYMENT TERMS: For contract furniture and other services, balance is due in full net thirty (30) days from date of invoice. Buyer agrees not to withhold payment on any invoice because of partial delivery or open punch list items.
- c. FREIGHT/TAXES: Unless noted, all applicable freight charges and sales taxes are not included in the quotation and will be invoiced as separate line items.
- d.
