*\*for all new connections, the City shall not be responsible for providing any meter pit parts (including setter assembly, service line and tapping saddle) and equipment, materials and labor trenching, backfill, and road restoration. The City shall provide the meter, MXU and ECR components, and will charge the customer account market cost for those components in addition to the connection fee.*

*\*\* Small users are defined as businesses and/or residences or dwellings with the number of fixture units less than 15 as defined by the National Standard Plumbing Code.*
